## Make Sure That The Detox Clinic and Program You Choose Are The Right Fit For Your Family Member

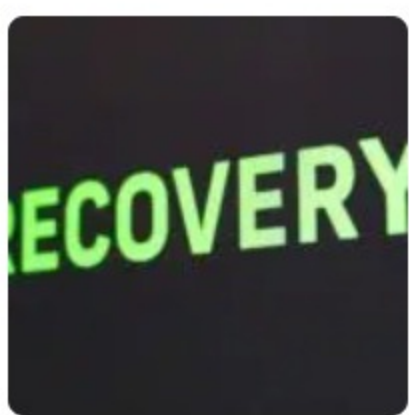

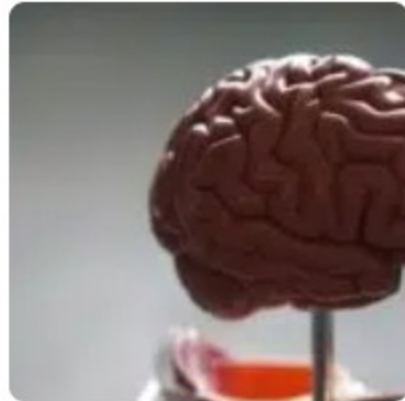
